OCTOBER 4, 2010

AN ORDINANCE AMENDING THE MILLWOOD COMPREHENSIVE PLAN

WHEREAS, the Washington State Legislature passed, and the Governor signed into law, the Growth Management Act in 1991, and

WHEREAS, the City of Millwood was required to develop and adopt a comprehensive plan according to the Growth Management Act in 1994; and

WHEREAS, the City of Millwood may only consider proposed amendments to the Millwood Comprehensive Plan one time each year in January; and

WHEREAS, a proposal to amend the Millwood Comprehensive Plan by creating a new chapter on historic preservation was submitted during the 2010 annual amendment cycle; and

WHEREAS, the Millwood Planning Commission held public hearings on the proposed amendments and submitted its recommendation to the City Council to approve the amendments; and

WHEREAS, the amendments proposed for approval under the 2010 annual amendment process are contained in the written recommendation of the Millwood Planning Commission, dated July 27, 2010, a copy of which is on file in the office of the City Clerk, and

WHEREAS, all requirements of the Growth Management Act RCW 36.70A including Public Notices and Public Comments, and the requirements of the State Environmental Policy Act RCW 32.21C have been met,

NOW, THEREFORE:

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF MILLWOOD,
WASHINGTON, AS FOLLOWS,


Section 1. That the Comprehensive Plan of the City of Millwood, Washington, is hereby amended to include the Historic Preservation chapter, file number CPA 10-01, as recommended by the Millwood Planning Commission.

Section 2. This ordinance shall be in full force and effect from and after its adoption and five (5) days after its publication or a publication of a summary of this ordinance in the official newspaper of the City.
