

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF  
MILLWOOD, WASHINGTON, AMENDING THE 2014 SALARY SCHEDULE;  
AND PROVIDING FOR OTHER MATTERS RELATED THERETO

WHEREAS, the City Council desires to amend the schedule of salaries and wages for city officers and employees for the budget year beginning January 1, 2014,

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF MILLWOOD WASHINGTON, AS FOLLOWS:

**Section 1. Schedule of Salaries and Wages.** The schedule of salaries and wages contained in Ordinance No. 457 is hereby amended to read as follows:

**Section 2. Repeal.** All ordinances, resolutions, laws, and regulations, or parts thereof in conflict with this ordinance are, to the extent of said conflict, hereby repealed.

**Section 3. Severability.** If any section, sentence, clause, or phrase of this ordinance should be held to be invalid or unconstitutional by a court of competent jurisdiction, such invalidity or unconstitutionality shall not affect the validity or constitutionality of any other section, sentence, clause or phrase of this ordinance.


