RESOLUTION #2014 – 11

A RESOLUTION AMENDING RESOLUTION #2014-08, ADOPTED NOVEMBER 12, 2013, AND ESTABLISHING THE AD VALOREM TAX FOR 2015

WHEREAS, the Council of the City of Millwood, Washington (the "Council") properly gave notice and conducted a Public Hearing on October 14, 2014, to consider the City of Millwood's (the "City") Current Expense Budget and Property Tax Levy for the 2015 calendar year, and

WHEREAS, at the time of such hearing on October 14, 2014, the Spokane County Assessor's Office had advised that the City's Property Tax Levy for the 2015 calendar year would be approximately \$365,909, and

WHEREAS, based on such information, the Council adopted Resolution #2014-08 on November 12, 2014, which established the City's Property Tax Levy for the 2014 calendar year in the amount of \$367,000, and

WHEREAS, on November 19, 2014, the Spokane County Assessor's Office provided the City a revised levy calculation summary showing that the maximum amount of the City's Property Tax Levy for the 2015 calendar year is approximately \$368,803;

NOW, THEREFORE, Be it resolved by the Council of the City of Millwood, Washington, that after hearing and after duly considering all relevant evidence and testimony presented, the Council determines that the City requires the City's Property Tax Levy for the 2015 calendar year in the amount of \$370,000 plus any administrative refunds provided by the Spokane County Assessor's Office made in order to discharge the expected expenses and obligations of the City and in its best interest;

NOW, THEREFORE, Be it further resolve that all resolutions, laws, and regulations, or parts thereof in conflict with this resolution are, to the extent of said conflict, hereby repealed.


